



GENERAL TERMS AND CONDITIONS OF SALE

Registration and participation in MY HOUSE DANCE CAMP implies full acceptance of these terms and conditions.

REGISTRATION - RESERVATION

Registration is done on the website www.myhousedancecamp.com

The online reservation request is definitively registered on receipt of the 1st deposit (445€ for payment in 2 instalments and 290€ for payment in 3 instalments).

The 1st deposit must be made within 15 days of the reservation request.

The balance of the amount of the stay must be paid 30 days before the departure without any reminder from the association.

The final registration will be validated at the last payment at the due date, according to the choice of the payment, and at reception of the administrative documents requested (identity card, medical certificate of not contraindication to the intensive practice of sport, or letter of discharge).

After 05.08.2024, payment must be made in one instalment.

Any delay in the payment of the stay can lead to the cancellation of the reservation.

RATES: Rates are published subject to errors or omissions.

The total cost of the camp is 890€ (promotional price 850€ before May 20th 2024)
Possibility to pay in 1 time, 2 times or 3 times without fees.

Methods of payment before May 20, 2024:

In 1 time : 850€ at registration

In 2 times :

- 425€ at registration

- 425€ before August 15th included

In 3 times :

- 290€ at registration

- 280€ before June 20, 2024

- 280€ before August 15, 2024

After May 20th, the price of the stay is 890€. Only the payment in 1 or 2 times will be accepted.



Methods of payment after May 20, 2024 :

In 1 time : 890€ at registration

In 2 times :

445€ at registration

445€ before August 15th included

Any delay in payment will result in the cancellation of the registration.

The price includes :

- Accommodation 7 days/6 nights from September 22, 2024 5 pm to September 28, 2024 9 am in formula
- Full board (breakfast, lunch, dinner buffet, all you can eat at Neaclub *Les Balcons du Lac) in a double room
- Free access to the swimming pool, solarium and sports field
- Dance workshops (24 workshops, 18 of which are guaranteed)
- Followed trainings, conferences, evenings, Battle
- Membership and application fees
- Bed linen and towels
- Cleaning at the end of the stay

The price does not include :

- Transportation
- The shuttle " Annecy bus and train station - Neaclub Sévrier " Supplement of 10€ for the return transfer
- Single room supplement 15 euros/pers/night : 90 € for the week
- Drinks taken at the bar and during the evening events
- Late return of the room on Saturday September 28, 2024 after 9:00 am : 25€.
- Personal expenses

The participant agrees to return the occupied room to its original state and at his/her own expense in case of deterioration.

The free outdoor parking lot is not closed or guarded. Neaclub and My House Dance Camp cannot be held responsible for any damage that may occur in the parking lot.

METHOD OF PAYMENT

Are accepted :

- Bank transfer

TRANSPORTATION

If you want us to organize your shuttle from Annecy station to the club and back, you will have to pay the sum of 10 euros before 06.08.2024.

You must also send us information about arrival and departure times at Annecy station by August 15 at the latest.

Our responsibility is engaged only at the time of your pick-up at the Neaclub hotel and until your departure from the Neaclub hotel in Annecy.



CANCELLATION OR MODIFICATION OF STAY

Cancellation and modifications by the association My House Dance Camp :

The association My House Dance Camp reserves the right, if the circumstances require it or if the number of registered participants is insufficient, to modify or cancel the stay with the obligation to inform the participants at least 15 days before the departure date. In this case, My House Dance Camp association will propose either the complete refund of the paid sums, or the inscription on another stay organized by My House Dance Camp association in the course of the year 2025, without the participants being able to claim a compensation.

For safety reasons or in case of exceptional circumstances or major impediment, My House Dance Camp Association may be obliged to modify the place of stay, the program or the services. In this eventuality, My House Dance Camp Association will propose replacement services of equivalent or superior quality without extra charge, or, failing that, the reimbursement of the services not provided. My House Dance Camp may have to modify the dates and times of the stay according to the availability and imperatives imposed by the railway companies. In the event of strikes or changes of schedules imposed by these same companies, we will try to seek and propose solutions adapted to the difficulties encountered.

Cancellation by the participant:

All cancellations must be justified by a document attesting to the impossibility of carrying out the course and sent by e-mail or by registered letter with acknowledgement of receipt.

The terms of reimbursement are as follows:

- For any cancellation before august 01 th 2024, only the 70€ registration fee and the 10€ membership fee will be kept.
- For any cancellation after august 01 th 2024, the association My House Dance Camp keeps 1/3 of the price of the stay, that is 296,67€.
- For any cancellation occurring after august 15 th 2024, the association My House Dance Camp keeps 50 % of the price of the stay, that is to say 445€.
- For any cancellation after September 01 th 2024, the totality of the price of the stay is due.

No reimbursement will be made for late arrival, early departure or absences during the stay.

CLAIMS

Any complaint occurring during the stay is useful to all and allows the organizer to intervene quickly. The My House Dance Camp team will be available to answer your questions upon arrival and during your stay. Post-stay complaints should be sent by email to: myhousedancecamp@gmail.com within two weeks after the stay, after this period, no consideration will be given.

RESPONSIBILITY

Participants under 18 years of age are required to provide parental authorization to participate in the program. All minors must be accompanied by their legal guardian.
